

Dear Parker School JR/HS Families,

It is hard to believe quarter 1 has come to an end and we have completed our first week of quarter 2!

I have compiled a list of frequently asked questions to documents that are on the backside of this letter which will be sent home with your child, allowing you to agree or decline Quarter 2 privileges.

Please read carefully and contact me if you have any questions.

- **Junior/Senior ONLY Open Campus Privilege (Study Hall/Homeroom/Dual Credit):** As part of an incentive for our Juniors and Seniors to give their best effort in their courses, we are offering the privilege of leaving campus during study hall, homeroom, lunch, and dual credit time periods to Junior and Senior ONLY.
 - To qualify for Junior/Senior ONLY open campus privileges during Study Hall/Homeroom/Dual Credit, 11-12 grade students must:
 - ✓ Must maintain at least a C-average (1.67 on the 4.0 scale), with no “F” grades in any subject.
 - ✓ Are not allowed to chauffeur other students, one child per vehicle.
 - ✓ Must be on time for the next class period (see tardy policy).
- **High School Open Campus Privilege (lunch):** As part of an incentive for our high school students to give their best effort in their courses, we are offering the privilege of leaving campus during lunch.
 - To qualify for high school open campus students must:
 - ✓ Must maintain at least a C-average (1.67 on the 4.0 scale), with no “F” grades in any subject.
 - ✓ Are not allowed to chauffeur other students, one child per vehicle.
 - ✓ Must be on time for the next class period (see tardy policy).
- **Classroom Tardy Policy:** If tardy to a class (periods 1-8), students will be marked tardy in DDN which will be communicated to the student by the classroom teacher. Tardies will be checked by Mrs. Johnson on Wednesday of each week. 5 tardies per quarter will result in a Saturday detention. Parents will be contacted after 3 tardies in hopes of correcting the issues. (See page 11 of the Student Handbook).
- **Eligibility Policy:** Student grades are easily accessible through DDN at any time by students and parents. Student eligibility will be checked by the office every two weeks along with mid-term and end of quarter time periods. Those students and the student’s parents/guardians who are ineligible will be notified by the school office/Mrs. Johnson. Students who are ineligible will lose all open campus privileges until the next two-week reassessment period. Coaches will monitor athletic eligibility.
- **Attendance Policy:** Attendance is tracked daily for in-person and remote learners, parents of our in-person learners are notified daily of each absence. Teachers will contact remote learners each week to communicate assignments and Zoom times. Students not attending school regularly in person or via remote learning will be contacted every five days (Fridays) by Mrs. Johnson, truancy will be filed every ten days.
